## PROFILE OF INSTITUTION

The College of Nursing established in 2011 was situated in Karukachal, Kottayam and shifted to Kuttapuzha, Thiruvalla by August 2019. Believers Church Medical College Hospital (Managed & Administered by Believers Eastern Church) is the Parent hospital holding a bed capacity of 500 beds in various specialities. Affiliation sort from other private hospitals for the fulfilment of student's requirements, healthcare, initiatives, charitable activities, community development programs, rehabilitation projects and relief works.

This Prospectus relates to admission to Four Year B.Sc. Nursing Degree Course for the Academic year 2023-2024 in College of Nursing Guru Education Trust, Kuttapuzha, Thiruvalla.

This prospectus contains rules and regulations for the admission and selection of all seats for B.Sc. Nursing Degree Course for the Academic Year 2023-2024.

The Conditions in this Prospectus is subject to modification/addition/deletion, as may be deemed necessary by the Management and will be subject to further orders, if any, passed by appropriate authorities / Courts of law.

Applicants are required to go through the Prospectus carefully and familiarize themselves with all relevant information. They are also encouraged to visit the official Website of the College, i.e., for more details.

## HOW TO APPLY

The prospectus and application forms for B.Sc. Nursing Degree Courses are available on the website ([www.guruinstitute.org](http://www.guruinstitute.org)). Submission of more than one application by a candidate will lead to rejection of the application.

*Office functions from 9.00 am to 4.30 pm on all working days.*

## Remittance of Application Fee & Submission of Application Form

There will be **six steps** for the submission of application form and all steps are Mandatory. Candidates must complete all the steps of the submission process.

**Step 1:** Open the website URL <http://www.guruinstitute.org/> on your available browser(Prefer a higher version of Chrome for best compatibility)

**Step 2:** On the home page itself you can see the "**Click here**" button just below the heading "**B.Sc. Nursing Admission 2023-24**".

**Step 3:** By clicking the "**Click here**" button you will get redirected to the "**Terms & Condition**" page and from there click the "**Next**" button.

**Step 4:** Fill in all information in the opened application form and "**click submit button**".

**Step 5:** By clicking submit button application form will be open which has to be completely filled by yourself, Use the **print button** to take a printout of your application and use the "**pay now button**" to submit the application fee amount of Rs 750/-.

**Step 6:** Pay an amount of Rs 750/- for the completion of the application procedure.

- *Application fee is non-refundable.*

#### **SUBMISSION OF APPLICATION FORM**

- The candidate should visit the college website and follow further instructions to submit the online application form.
- Upload the photo of the candidate in JPEG format up to 500 KB size.
- Upload all the required certificates in JPEG or pdf format (each certificate size upto 1 MB)
- After the successful submission of the online application and uploading the relevant documents, the link will be sent to the candidate's email ID for downloading the acknowledgement receipt within two working days.

## **ADMISSION & PAYMENT OF FEES**

The students shall pay all fees of the 1<sup>st</sup> semester of the course at the time of admission which will not be refunded at any circumstances.

### **Fee stipulated by the Fee Regulatory Committee/Govt. of Kerala is as follows:**

All other fees are due to statutory bodies (KUHS, KNMC & INC) as and when notified later by the Government.

If any candidate discontinues the course, after the closing of admission as notified by the authority, the candidate has to pay the full fee of their course (4 years). Transfer Certificate will be issued only after payment of the above amount. Also, Legal proceedings will be initiated against the student/parent for the realization of the full amount of fees.

### **NRI SEATS**

The Management is entitled to fill up to 15% of the total seats in the NRI category by admitting qualified students who are dependents of NRIs. According to GO(MS)No.243/2014/H&F WD dated 06.08.2014, "An Applicant who depends upon his/her Father / Mother / Brothers and Sisters (inclusive of first cousins) / Husband / Wife / Brothers and Sisters (inclusive of first cousins) of Father or Mother / Half Brother / Half Sister / Adopted Father or Adopted Mother who is working abroad" will only be eligible to apply in the NRI category seats.

As per the Fee Structure prescribed for the NRI category seats by AFRC Order no. FRC50/22/B.Sc. P.B.Sc./M.Sc. (N)/ dated 20.06.2022, the Annual Tuition Fee payable by students being admitted under the NRI category seats is Rs.95,000/- per year. All other fees including special fees are applicable to students admitted under the NRI.

The merit list will be published within one week of the last date of submission of the application. The admission procedure will be completed by the third week of August 2023. The commencement of classes will be announced on the day of admission. The cut-off date of admission to B.Sc. Nursing will be decided based on notifications issued by INC, KNMC and KUHS.

## **NRI STUDENTS**

- Relationship certificate of the Sponsor and student to be issued by the Revenue Authorities (Relationship should be established). If the sponsor is the Father/Mother of the applicant, educational certificates of the applicant containing the name of the sponsors shall be accepted.
- Overseas Employment Certificate issued by the Employer, attested by the Embassy and if self-employed, it should also be attested by the Embassy. In case of non-submission of the Embassy Certificate, the endorsement in the passport of the sponsor about the employment by the Embassy/Consulates Hall be accepted. Certificate issued by the Embassy/Consulate stating that the sponsor is a Non-Resident Indian (NRI) or an Overseas Citizen of India (OCI) or the green card documents shall be accepted in lieu of the Overseas Employment Certificate issued by the Employer and attested by the Embassy.
- Passport with Visa stamped on it and attested by the Embassy.
- A self-affidavit of the relationship between the sponsor and the candidate (Sponsor certificate).
- The sponsor should be an Indian Citizen/Overseas citizen of India/Person of Indian Origin and relevant documents to prove the same.

## **ELIGIBILITY CRITERIA**

### ***Criteria of eligibility for admission and selection Schedule***

#### **Academic:**

- i. Candidates who have passed Higher Secondary Examination of the Board of Higher Secondary Education of Kerala or equivalent examinations recognized by any of the Universities in the State of Kerala with Aggregate of 50% marks in Physics, Chemistry, Biology and 50% marks in English only are eligible for admission. A Rank List will be prepared on the basis of total marks secured for **PLUS TWO** examinations (PLUS ONE mark will be excluded). Those who completed PLUS TWO outside Kerala/India should submit an equivalency certificate from the Board of Higher Secondary Education of Kerala along with their migration certificate.

#### **Age:**

- i. Applicants should have completed 17 years of age on 31<sup>st</sup> December 2023. No relaxation of the minimum age will be allowed.

- ii. Self-attested copy of the relevant page of school record namely SSLC/ICSE/CBSE/Certificate showing the date of birth/copy of the birth certificate should be produced at the time of admission.

### **SEAT ALLOCATION & SELECTION**

The annual intake is 60 for B.Sc. Nursing. 50% of seats are allotted for LBS Students, 35% for Management Students and 15% for NRI students and it is based on merit.

**Resolution of the tie while ranking:** In case of a tie in the total marks, the marks in Biology will be counted. If there is still a tie, the marks in Chemistry and Physics will be counted. If a tie still exists, the age of the candidate will be taken into account, and the elder will be preferred to the younger.

**Validity of the merit list:** The published merit list will be valid till 30-09- 2023 or the date up to which the merit lists shall be kept alive in terms of instruction/direction of competent authority.

### **LAB FACILITIES**

Well- equipped Laboratories in all specialities such as Anatomy, Physiology, Fundamentals of Nursing, Nutrition, Computer, Community Health Nursing, Advanced Medical-Surgical Nursing, Pediatric Nursing, MCH& AV aids as recommended by INC, KNMC & KUHS.

### **LIBRARY**

A full-fledged library containing more than 3600 books.

### **HOSTEL**

Hostel facilities are available for students.

### **SPECIAL INSTRUCTIONS.**

- i. Ragging: Ragging in any form is strictly prohibited in all member colleges. Any student who indulges in any form of ragging will be subjected to penal action as per the provisions of the law. Also, the student will be expelled from the college as detailed in the law concerned and as per the Honorable Supreme Court of India's directions in this regard.

## OUTLINE OF THE B.Sc. NURSING DEGREE COURSE

The duration of the course is four years. The rules regarding the method of selection for the B.Sc. Nursing Degree Courses and other rules regarding the admission process are provisional and subject to the guidelines, orders and instructions issued by the Government, Indian Nursing Council, Kerala Nurses and Midwives Council, Kerala University of Health Science, and Admission Supervisory Committee. All the applicants seeking admission to the B.Sc. Nursing Degree Courses for the academic year 2022-23 are bound by the final decisions of the above-mentioned statutory bodies and Courts of Law.

### Core Competencies for Nursing and Midwifery Practice by B.Sc. Nursing Graduate

**The B.Sc. Graduate Nurse will be able to:**
